# Rocky Top Kennel LLC Boarding Contract

**This is a contract between Rocky Top Kennel LLC and the pet owner whose signature appears below hereinafter called "owner".**

1. Rocky Top Kennel LLC agrees to exercise due and reasonable care, and to keep the kennel premises sanitary and properly enclosed. The pet(s) are to be fed properly and regularly, and to be housed in clean, safe quarters.
2. All pets boarded or otherwise handled or cared for by Rocky Top Kennel LLC and kennel staff are held without liability for loss or damage from theft, fire, injury, escape, disease, or death.
3. Owner specifically represents that the pet has not been exposed to rabies or distemper within 30 days prior to boarding and is in good health.
4. The owner understands that even with vaccinations, illnesses in dogs may occur. Particularly, the owner understands that even if the dog is vaccinated for Bordetella there is a chance that the dog may contract kennel cough. The owner agrees that Rocky Top Kennel LLC will not be held responsible should the dog(s) become ill, including contracting kennel cough.
5. If the pet becomes ill or if the state of the animal's health otherwise requires professional attention, the kennel, at its sole discretion, may engage the services of a veterinarian or administer medication or give other requisite attention to the animal. These expenses thereof shall be paid in full by the owner.
6. If a single kennel occupied by multiple pets requires separation due to fights, food aggression, etc, owner hereby understands there will be changes in kennel pricing.
7. All charges incurred by the owner shall be payable upon pickup of pet(s) and owner further agrees that the pet(s) shall not leave the kennel until all incurred charges have been paid. The kennel shall have a lien on the pet(s) for any and all unpaid charges resulting from boarding said pet(s) at the kennel. The owner hereby agrees that in the event the boarding charges are not paid when due in accordance to this contract, the kennel may exercise its lien rights upon ten day written notice given by the kennel to the owner by certified mail to the address shown on contract.
8. Photos or video footage may be taken of pets while boarding. Owner agrees to allow Rocky Top Kennel LLC to use any image, video or likeness of pets while using the kennel services.
9. This contract shall remain valid hereinafter the date signed below and shall pertain to all pet(s) left in the care of Rocky Top Kennel LLC.
